Conditions of Participation:

- Registration is limited to a maximum of 75 institutions.
- Participating institutions must hold US Regional Accreditation or recognition from their host country's Ministry of Education. *Verification may be requested.*
- Satellite campuses are required to register under the name of their main campus.
- Participation is limited to members of the admission/recruitment staff, alumni, professors or current students. Participation by institutional agents is not permitted.
- Participation is limited to a maximum of two persons per institution.
- Priority is given to current CIS Higher Education members.

Deadline: Friday 16 July 2010

Registration is complete only after full payment has been received and is confirmed on a first-complete, first-served basis. Due to space limitations, only complete registrations will be processed. Please bear in mind that the fair fills very quickly and that late registration may not be possible.

2. Clearly and thoroughly complete the form and check the box for CIS Education Day in Istanbul
(a separate form must be submitted for each event in which you wish to participate)
3. Include your registration fee payment of US\$395 for payments received on or before 16 July or US\$500 late registration for payments received after 16 July

Registration Fee Payment:

Payment may be made by institutional check (made payable to CIS) or via credit card. Institutions wishing to pay the registration fee via credit card may do so by contacting the CIS Office of Higher Education at cisus@cois.org. (Please notate 'Education Day in Istanbul' on all payments.)

Late Registration:

Late registration (for payments received after 16 July) is accepted on a space available basis and only at the late registration fee. Those received after 30 July will be accepted on a space available basis and *without inclusion in event publicity*.

Cancellation & Refund Policy:

Cancellations are accepted via fax or e-mail *only* according to the following cancellation and registration fee refund policy:

- Dated on or before 16 July ~ full refund of paid registration fee
- Dated after 16 July, but on or before 30 July ~ 50% refund of paid registration fee
- Dated after 30 July ~ No refund

Upon receipt of completed registration form, registrants will receive an initial acknowledgement. A detailed confirmation including instructions for advance shipments of university brochures and recommendations for hotel accommodations will be distributed to all registrants via e-mail by late August 2010.
