- Select the tour(s) for which you would like to apply. CIS membership is required for tour participation, however, non-member applications will be considered on a space-available basis. Non-CIS member institutions may apply for participation in only one tour, after which membership is required for participation in subsequent tours. For further information about the tours listed, please see the accompanying itinerary, included features, and terms and conditions.
- CIS accepts deposits via check, wire transfer or credit card. All transactions must be in U.S. dollars.
 - Checks must be drawn on a bank with a U.S. branch. If you have selected multiple tours send one check made payable "CIS". If you have selected only one tour please make your check payable to the appropriate tour (see the Terms and Conditions for your tour).
